

## **Rare Vintage & Specialty Product Auction Instructions**

- (a) Product auctions are open to both individual consumers and licensees.
- (b) Persons under the age of 21 are strictly prohibited from participating in any product auction.
- (c) In order to be eligible to participate in any product auction, individual consumers and licensees must sign up for or have an existing customer account through [FineWineAndGoodSpirits.com](http://FineWineAndGoodSpirits.com) and must provide the email address associated with such account on the bid sheet.
- (d) The bid amount set forth on the bid sheet represents the full price (prior to applicable sales tax being added) that the bidder is agreeing to pay, if this bid is determined to be the highest and winning bid for the specified auction lot.
- (e) Any bid amount submitted by a licensee will be viewed as a wholesale price bid net of any licensee discount. In other words, the submitted bid amount must reflect the full wholesale price that a licensee is willing to pay (prior to applicable sales tax being added). For purposes of evaluating a licensee (wholesale price) bid against an individual consumer (retail price) bid for any auction lot, the PLCB will calculate what the retail price of the auction lot would be based on the licensee's submitted bid amount. To calculate the retail price, the PLCB will divide the licensee bid amount by 0.9, which is reflective of the fact that a licensee is otherwise entitled to a 10 percent discount from the retail price under the Liquor Code. If the calculated retail price based on the licensee's submitted bid amount is higher than a competing bid from an individual consumer, then the licensee's bid will prevail. However, the licensee will only be required to pay the actual amount of their submitted bid, which is the wholesale price for purposes of a product auction, plus applicable sales tax. No other discounts will be given.
- (f) Bid amounts must be in whole dollars, clearly written on the bid sheet, and must meet or exceed the minimum bid amount established for each product. A separate bid sheet must be submitted for each bid.
- (g) This auction lot is subject to a reserve amount that must be met before the product will be sold to the winning bidder.
- (h) This bid sheet is specific to and applicable only for the auction lot described on this bid sheet.
- (i) Only one bid amount may be entered on this bid sheet; separate sheets may be used to submit additional bids.
- (j) Print this bid sheet and submit with required bid surety of \$2,500 (cashier's check or certified check only) in a sealed and labeled envelope. Complete bid packages must be received by 4 p.m. on April 5, 2019. Only one bid surety is required when the same bidder submits multiple bids for the same auction lot. Bids must be carried by hand or mailed (USPS, UPS, FedEx, etc.) to:
